All averages used must be USBC certified. **The 10-Pin Rule 319a2 does not apply.** USBC Rule 319 – It shall be each bowler’s responsibility to verify the accuracy of her average. Failure to use the correct average shall disqualify score if submitted average is lower than the correct average or will stand as bowled if submitted average is higher. USBC Rule 319d & 319e does not apply. **Handicap:** 80% of difference based of 210. The minimum average used will be 100. Errors must be reported to tournament secretary within 24 hours. Team Captains please report to tournament 30 minutes before scheduled bowling time. **All Entrants Must Be Members of USBC** - Non-members can qualify for entry by paying an associate membership fee of \$20.00 - USBC Rule 300C2a or pay \$5.00 participation fee - USBC Rule 300C1b (Participants who pay the participation fee are not eligible for USBC awards). **Entry Fee** - Prize fund \$12.00 - Bowling \$9.50 – Expense \$3.50. Total each girl per event \$25.00. **1-4 Prize pay-out.** Prize fee returned 100%. **If the bowler bowls doubles, she is required to bowl singles at the same time. There is no exception. EVERYONE THAT ENTERS THE TOURNAMENT THIS YEAR IS ENTERED IN ALL-EVENTS THAT IS HANDICAP.** 1-10 Prize pay-out for All-Events. Prize fee returned 100%. USBC Rule 326-A Co-Champions may be declared.
